May kindly see the online application of Sri Abhay Rajvanshi, Addl. Civil Judge (Junior Division), Bulandshahr regarding grant of permission to visit Mauritius along with his would-be wife who is also a judicial officer (officer id UP 3327) after his marriage, tentatively from 03.12.2023 to 09.12.2023.

In his application dated 21.10.2023, Sri Abhay Rajvanshi has stated that he is getting married on 25.11.2023 and wants to go on holiday abroad i.e Mauritius after marriage tentatively from 03.12.2023 to 09.12.2023 during his earned Leave (that he would take for marriage). He has also stated that on the trip he would accompany his wife who is also a Judicial Officer in Uttar Pradesh Judicial Services (JO Code UP 3327) and also has a valid Indian passport. Furthermore, his would-be wife is also applying separately for permission to travel abroad with him from her portal & VISA for Mauritius is 'on arrival'. He has also added that he has never visited any foreign country since his date of joining and the expenses of the proposed foreign trip would be borne by the officer and his would-be wife respectively. He has also attached a copy of his passport and his passbook, having balance amount of Rs. 12,55,206/-. The proposed expenses of the foreign travel as suggested by the Travel Agent is Rs 1,58,321 for two adults (copy of the same can be seen as attachment). He has also submitted the following undertakings, as per requirement of Hon'ble Court's Circular letter:-

1. That by his abroad visit, no dilemma is likely to create before the Government of India or before Government of Uttar Pradesh.
2. That such type of request for abroad visit was not refused to him earlier.
3. That he has never visited any foreign country before or after his joining.

Thereafter, through online objection dated 26.10.2023, the officer has been asked about his submission relating to his visit as the duration of the visit is falling in working days of the Court. In reply, the officer has stated that as per their proposed plan the officer along with his would-be wife is planning to visit Mauritius on the proposed dates i.e. 03 to 09 December 2023 for their Honeymoon and as this is once in a lifetime visit after marriage, the same time won't return again. He has, therefore, requested to Hon'ble Court, to grant him permission to visit Mauritius alongwith his would-be wife after marriage for the aforesaid period.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, provided by concerned sections, no vigilance/ departmental enquiry is pending against Sri Abhay Rajvanshi. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities, the Judicial officers shall seek permission before applying for VISA. Now, in the instant case the officer is going to visit Mauritius alongwith his wife after their marriage, who is also a Judicial Officer, for their honeymoon i.e. for pleasure trip tentatively from 03.12.2023 to 09.12.2023, which includes five (5) working days of the Court alongwith Sunday and second Saturday. It is also pertinent to mention here that the officer has submitted his clarification regarding his pleasure trip, falling in working days of the Court that they are going for their honeymoon and this is once in a lifetime visit after marriage, the same time won't return again. However, it is at the discretion of the Hon'ble High Court either to grant her permission or to pass any order which deems to be proper. Here, it is also to point out that his wife namely Sushri Deeksha Bharti (Officer Id. no. UP 3327) has also separately applied for the same permission, which has also been processed on a separate e-service Id S00036402023. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission, the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned,

for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by Hon'ble the Chief Justice. Recently, vide order dated 23.04.2023- Last modified on 29.08.2023 regarding reconstitution of different Committees, Hon'ble The Chief Justice has been pleased to form a single Hon'ble Judge Committee i.e. Hon'ble Senior Judge (J-1) to deal with the matter of grant of permission to Judicial Officers to visit abroad

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahr for kind perusal and if His Lordship approves, Sri Abhay Rajvanshi, Addl. Civil Judge (Junior Division), Bulandshahr may be granted permission, to visit Mauritius along with his would-be wife who is also a judicial officer (officer id UP 3327) after his marriage, tentatively from 03.12.2023 to 09.12.2023, as requested, subject to approval by Hon'ble Mr. Justice Manoj Kumar Gupta, Senior Judge (J-1), as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 23.04.2023-Last modified on 29.08.2023 of Hon'ble the Chief Justice, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with him, may be handed over by him before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
