May kindly see the online requisition dated 04.11.2023 of Sushri Shreya Solanki, Additional Civil Judge (Junior Division), Raebareli, whereby she has requested for inclusion of her LL.M. Qualification in her service records. In support of the same, Sushri Shreya Solanki has furnished her LL.M. credentials comprising attested copies of Mark-sheets of 1st Year dated 10.12.2022 and 2nd year dated 28.08.2023 & Degree Qualification dated 15.09.2023 as well as copy of the online permission letter for pursuing the aforesaid course along-with a letter dated 13.08.2018 of the Director, Directorate of Distance Education, Kurukshetra University, Kurukshetra and letter no. F.No.122-1/2017(DEB-IV) Dated: 25.06.2018, as supporting documents for inclusion of the aforesaid degree in her service record.

In this connection, it is pertinent to mention here that Sushri Shreya Solanki in her application has submitted that she pursued the above-mentioned LL.M. course after joining the judicial service on being granted the permission of this Hon'ble Court to pursue the said course, the copy of online permission letter has been attached herewith by attachment dated 29.11.2023 under the heading "Permission of Exam".

In this regard, an objection dated 07.11.2023 was raised by this office for furnishing the attested copies of LL.M. credentials as well as copy of documents related to recognition of Kurukshetra University, Kurukshetra, Haryana and approval of the aforesaid course. In reply, thereto, she has furnished desired documents by attachment dated 29.11.2023. Further an objection dated 19.12.2023 was raised for clarification with respect to the year of exam of 1st year and 2nd year & in reply she has furnished clarification by submission dated 21.12.2023.

In this context, it is submitted that Sushri Shreya Solanki, aforesaid joined the U.P. Judicial Service on 15.11.2019 as Additional Civil Judge(Junior Division), Bulandshahar. Besides, as evident from submitted attested copies of Mark-sheets of both years and the Degree qualification of LL.M., she has completed LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 15.09.2023 for the examination year 2022 and thus said qualification may be included in her service-records.

Further, It is noteworthy to mention here that a note in this regard was placed before the then Hon'ble Administrative Judge, Raebareli and after perusal vide order dated 15.03.2024, His Lordship had been pleased to pass the following order :

"The certificate issued by the concerned University dated 13.08.2018 appears to be not in consonance with the Letter No. 122-1/2017(DEB-IV), dated 25.06.2018 of UGC, Distance Education Bureau, New Delhi. Let it be clarified."

In response thereof, the Officer has replied on 06.05.2024 by merely attaching documents which have been already attached earlier. Therefore, vide objection dated 07.08.2024, she was informed about this fact and requested to submit appropriate clarification in compliance with the order dated 15.03.2024 of Hon'ble The Administrative Judge. Now, she has replied the following, in verbatim:-

"I have been enrolled in LLM program through distance education in Kurukshetra University for the session 2019-2021, which has been recognised by UGC. This is in consonance with certificate of university dated 13.08.2018 and letter of UGC dated 26.06.2018".

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sushri Shreya Solanki, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems appropriate that the aforesaid online requisition dated 04.11.2023 of Sushri Shreya Solanki, Additional Civil Judge (Junior Division), Raebareli may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Arvind Singh Sangwan, Administrative Judge, Raebareli for His Lordship's kind perusal and order to the effect that a copy of her online requisition along with copy of Mark-sheets (both years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sushri Shreya Solanki, Additional Civil Judge (Junior Division), Raebareli, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter?
