

## **Registrar (Judicial) (Budget)**

May kindly see the online application of Sushri Bhawana Sharma, Nyayadhikari, Gram-Nyayalaya, Rudauli- Ayodhya regarding grant of permission to visit Italy and Germany from 10.06.2024 to 17.06.2024 along with her husband.

In her application, Sushri Bhawana Sharma has stated that she is getting married on 28.11.2023 and wishes to visit Italy and Germany with her husband from the period of 10.06.2024 to 17.06.2024. She has a valid passport (No. S8153012) which was issued on 15.10.2018 at RPO, Ghaziabad, and is valid till 14.10.2028. She has added that she has never been to any foreign country since the date of her joining and the expenses of her proposed foreign trip would be borne by the officer from her Savings Account Number 39001895286, maintained with SBI, Modinagar, U.P., having a balance of Rs. 5,52,792/- (copy of passbook can be seen under attachment heading Annexure-I). Proposed expenses of the foreign travel is approximately Rs. 3,00,000/- (estimated expenditure list can be seen under attachment heading Annexure-II). She has also submitted following declaration/ details/ information as per Hon'ble Court's C.L. dated 27.05.2017:-

1. That by her abroad visit, no dilemma is likely to create before the Government of India or before the Government of Uttar Pradesh.
2. That such type of request for abroad visit was not refused to her earlier.
3. She has never visited any foreign country before and also since the date of her joining.
4. Copy of Passport can also be seen as attachment.

She has, therefore, requested to Hon'ble Court to grant her permission to visit Italy and Germany alongwith her husband for the aforesaid period in summer vacation.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, no vigilance/ departmental enquiry is pending against Sushri Bhawana Sharma. It is pertinent to mention here that the duration of her visit is from 10.06.2024 to 17.06.2024, which falls during the summer vacation of the Hon'ble Court thus it appears that her visit does not include any working days of the Hon'ble Court. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. In the instant case the officer has stated that she wants to visit Italy and Germany from 10.06.2024 to 17.06.2024 during summer vacation alongwith her husband. Now its upto the discretion of Hon'ble The Chief Justice and Hon'ble Administrative Judge, Faizabad, to grant her permission to visit Italy and Germany alongwith her husband from 10.06.2024 to 17.06.2024 during summer vacation or to pass any other order. In this connection. It is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Recently, vide order dated 30.11.2023 relating to re-constitution of Committees, Hon'ble The Acting Chief Justice has been pleased to change the single Judge Committee appearing at sl. no. 3 of the list of Committees dated 23.04.2023- last modified on 29.08.2023, and Hon'ble Mr. Justice Anjani Kumar Mishra is nominated in the said Committee, to deal with the matters relating to grant of permission to Judicial Officers to visit abroad.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Faizabad for kind perusal and if His Lordship approves, Sushri Bhawana Sharma, Nyayadhikari, Gram-Nyayalaya, Rudauli- Ayodhya be granted permission, to visit Italy and Germany from 10.06.2024 to 17.06.2024 alongwith her husband, as requested,

subject to approval by single Judge Committee of Hon'ble Mr. Justice Anjani Kumar Mishra, as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 30.11.2023 of Hon'ble The Acting Chief Justice relating to re-constitution of Committees, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
