May kindly see the online application received from Sushri Shilpa Jain, Civil Judge (Junior Division), (FTC) Bijnor regarding grant of permission to appear in preliminary examination of Delhi Judicial Services Examination, 2023.

In the aforesaid application, officer has stated that she wish to appear in Delhi Judicial Service Examination 2023 and through Advertisement dated 06.11.2023, Hon'ble High Court of Delhi has invited online applications for 53 seats in Delhi Judicial Service (Copy of Advertisement is enclosed as annexure-1 in attachment). The examination shall be conducted in three stages namely (a) Preliminary Examination (b) Main Written Examination and (c) Viva-Voice. (Scheme of Examination is enclosed as annexure - 2 in attachment) .The Preliminary Examination will be conducted on 10 December 2023 (Sunday). She has humbly submitted that she has already filled the Application form in anticipation of permission granted by Hon'ble High Court.(Application form is enclosed as annexure-3 in attachment). Therefore, she requested to kindly grant her permission to appear in the aforementioned examination. She will be obliged to Hon'ble High Court for this act of kindness. She will not seek any Study Leave for appearing in this exam. She is attaching all the relevant documents for kind persual and thanked for time and kind consideration.

In this connection, it is submitted that the officer has joined U.P. Nyayik Sewa on 15.11.2019. It is also pertinent to mention here that the matter was submitted before the then Hon'ble Administrative Judge, Bijnor but the same got returned without order due to change of Hon'ble Administrative Judge and in the meantime the date of preliminary exam has passed and it appears that the officer has appeared and cleared the same as she has also applied for grant of permission to appear in the mains exam of the same through different case Id. Now, It is desirable that she may be accorded ex-post facto permission to appear in the Preliminary Examination of Delhi Judicial Services Examination 2023, was rescheduled to be held on 17.12.2023 at present, if the Hon'ble High Court so desires.

May therefore, if approved, online application of the officer may be laid before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Bijnor Judgeship for His Lordship's kind perusal and if approved by His Lordship, ex-post facto permission be accorded to Sushri Shilpa Jain, Civil Judge (Junior Division), Bijnor for her appearance in preliminary examination of Delhi Judicial Services Examination, 2023, as requested, subject to the conditions mentioned above?
