It is also pertinent to mention here that the matter was submitted before the then Hon'ble Administrative Judge, Bijnor but the same got returned without order due to change of Hon'ble Administrative Judge and in the meantime the date of preliminary exam has passed and it appears that the officer has appeared and cleared the same as she has also applied for grant of permission to appear in the mains exam of the same through different case Id.
