

**Registrar (J)(Budget)**

May kindly see the online application/ request no. S00037332023 dated 17.11.2023 of Sri Arun Kumar Rana, the then Civil Judge (Junior Division), Mahoba, presently posted as Civil Judge (Junior Division), Kulpahar-Mahoba, whereby he has requested for inclusion of his LL.M. qualification in his service records.

Sri Arun Kumar Rana, in his application, has submitted that he has been granted permission from this Hon'ble Court to pursue the aforesaid LL.M. Course through Kurukshetra University, Kurukshetra, Haryana after joining the U.P. Judicial Services and he successfully pursued LL.M. distance learning course/program from Kurukshetra University, Kurukshetra and would like to add this educational achievement in his Service Record. He has, therefore, requested for addition of LL.M. Degree in service records.

In this regard, several objections dated 22.11.2023 & 30.11.2023 were raised by this office for attested LL.M. credentials as well as clarification with regard to recognition of Kurukshetra University, Kurukshetra and approval of aforesaid LL.M. Course for the relevant years. In reply thereto, he has furnished the desired documents & University related papers by attachment dated 23.11.2023 (at Sl. No. 3) & attachment dated 20.01.2024.

In support of his requisition, Sri Arun Kumar Rana, has furnished copies of his LL.M. credentials comprising attested copies of Mark-sheets of both the years and degree (at Sl. no. 5) by attachment dated 20.01.2024, recognition-related papers of the University (from attachment Sl. no.3), copy of permission letter of this Hon'ble Court regarding grant of permission (attachment Sl. no. 4) by attachment dated 23.11.2023.

In this context, it is submitted that Sri Arun Kumar Rana, aforesaid joined the U.P. Judicial Services on 15.11.2019 as Additional Civil Judge (Junior Division), Meerut. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.08.2022 for the examination year May 2021, for LL.M. Previous year marksheet dated 27.02.2021 as well as for LL.M. final year marksheet dated 09.02.2022.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Arun Kumar Rana, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems appropriate that the aforesaid online application/ request dated 17.11.2023 of Sri Arun Kumar Rana, Civil Judge (Junior Division), Kulpahar-Mahoba may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mrs. Justice Prashant Kumar, Administrative Judge, Mahoba for His Lordship's kind perusal and order to the effect that, a copy of online requisition/application dated 17.11.2023 alongwith the copy of Marksheets (both years) and Degree of LL.M. qualification, as well as attested copy of form of U.P. Nyayik Sewa of Sri Arun Kumar Rana, Civil Judge (Junior Division), Kulpahar-Mahoba, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in his service records?
