

### **Registrar (Judicial) (Budget)**

May kindly see the online application of Sri Aditya Jaiswal, Civil Judge (Senior Division) (Fast Track Court), Lakhimpur-Kheri regarding grant of permission to visit Paris and Switzerland for honeymoon purposes only along with his wife Krati Raj Varshney tentatively from 08.03.2024 to 16.03.2024.

In his application, Sri Aditya Jaiswal has stated that he wants to visit Paris and Switzerland along with his wife Krati Raj Varshney from 07.03.2024 to 14.03.2024 and the tour expenses per person would be Rs. 2,50,000/- approximately, which would be borne by the officer and his wife from their salary (copy of account statement of the officer and his wife can be seen as attachments). He has also stated that his wife is a practicing Doctor working in Saraswati Medical College, Hapur and she is not dependent on him. He has also submitted following declaration, which are as follows:-

1. That by his abroad visit no dilemma is likely to create before the Government of India or Government of Uttar Pradesh.
2. That such type of request for abroad visit has not been refused earlier as this is the first time he is applying for such type of request.
3. That before joining this service, he has obtained his passport (copy of the same can be seen as attachment).

Thereafter, through online objection, the officer has been asked to intimate his declaration relating to earlier performed visit, if any and also be asked to submit the status of performing visit as his visit is falling in the working days of the Hon'ble Court and also be asked to intimate the exact date of departure and return. In reply of the same, the officer has submitted following points:-

- He has not visited any foreign country earlier.
- He has stated that he got married on 26th of August 2023 (copy of marriage certificate can also be seen attachment) and this is their first abroad visit for honeymoon purpose which is a very special occasion for them and also comes once in a lifetime.
- Date of departure would be 08.03.2024 and date of arrival to India would be 16.03.2024.

He has, therefore, requested to Hon'ble Court to grant him permission to visit Paris and Switzerland for the aforesaid period.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, no vigilance/ departmental enquiry is pending against Sri Aditya Jaiswal. It is pertinent to mention here that the duration of his visit is from 08.03.2024 to 16.03.2024, which includes Mahashivratri holiday, second Saturday, Sunday, alongwith 06 (six) working days of the Hon'ble Court. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. In the instant case the officer has stated that he got married on 26th of August 2023 (copy of marriage certificate can also be seen attachment) and this is their first abroad visit for honeymoon purpose which is a very special occasion for them and also comes once in a lifetime. Now its upto the discretion of Hon'ble The Chief Justice and Hon'ble Administrative Judge, Lakhimpur-Kheri, to grant him permission to visit Paris and Switzerland alongwith his wife from 08.03.2024 to 16.03.2024 or to pass any other order. In this connection. It is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any

deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Recently, vide order dated 30.11.2023 relating to re-constitution of Committees, Hon'ble The Acting Chief Justice has been pleased to change the single Judge Committee appearing at sl. no. 3 of the list of Committees dated 23.04.2023- last modified on 29.08.2023, and Hon'ble Mr. Justice Anjani Kumar Mishra is nominated in the said Committee, to deal with the matters relating to grant of permission to Judicial Officers to visit abroad.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri for kind perusal and if His Lordship approves, Sri Aditya Jaiswal, Civil Judge (Senior Division) (Fast Track Court), Lakhimpur-Kheri be granted permission to visit Paris and Switzerland from 08.03.2024 to 16.03.2024; alongwith his wife, as requested, subject to approval by single Judge Committee of Hon'ble Mr. Justice Anjani Kumar Mishra, as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 30.11.2023 of Hon'ble The Acting Chief Justice relating to re-constitution of Committees, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with him, may be handed over by him before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
