May kindly see the online application/ request vide case id 37562023 dated 23.11.2023 of Smt. Rashi Tomar, the then Civil Judge (Junior Division), Ramabai Nagar, presently posted as Additional Civil Judge (Senior Division)/ACJM, Ramabai Nagar whereby she has requested for inclusion of her LL.M. qualification in the service records.

In support of the same, Smt. Rashi Tomar has furnished, copy of online permission letter of this Court regarding grant of earlier permission (attachment sl. no. 1) by attachment dated 23.11.2023 and her LL.M. credentials comprising attested copies of Mark-sheets of both the years(from attachment sl. no. 5-6) and degree (at attachment sl. no. 7) copies of recognition-related papers of the University (at attachment sl. no.8).

An objection dated 25.11.2023 was raised by this office with regard to requisite documents and necessary clarification & in reply, thereto, she has furnished the desired documents/clarification by response dated 11.01.2024.

In this context, it is submitted that Smt. Rashi Tomar aforesaid joined the U.P. Judicial Service on 18.06.2018 as Additional Civil Judge(Junior Division), Bulandshahar. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., she has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the examination year May 2022 for LL.M. II (final year) marksheet issued on 11.03.2023 as well as for 1st year issued on 05.07.2022. He has persued the aforesaid LL.M. Course with the prior permission of this Court and copy of the same has been furnished by attachment dated 23.11.2023 at sl. no. 1.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Smt. Rashi Tomar aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/request dated 23.11.2023 of Smt. Rashi Tomar, the then Civil Judge (Junior Division), Ramabai Nagar, presently posted as Additional Civil Judge (Senior Division)/ACJM, Ramabai Nagar may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Ramabai Nagar for His Lordship's kind perusal and if His Lordship approves, a copy of online application/request dated 23.11.2023 of Smt. Rashi Tomar, the then Civil Judge (Junior Division), Ramabai Nagar, presently posted as Additional Civil Judge (Senior Division)/ACJM, Ramabai Nagar along with copies of, Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of her form of U.P. Judicial Service, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in her service records?
