May kindly see the online application of Sri Rajan Rathee, Judicial Magistrate, Ambedkar Nagar at Akbarpur for grant of permission to sell his old Hyundai I20 car, intimated through application dated 25.11.2023

In his application, Sri Rajan Rathee has stated that he is the registered owner of Hyundai I20 car, bearing registration no. HR12 AK2520, which was purchased prior to the joining this service and now wants to sell his car to one Sri Ravinder Kumar R/o House no 232, Housing board colony, Sector 23, Sonipat, Haryana for Rs. 3,00,000/- (Copy of RC can be seen as attachment). The proposed purchaser is neither related to him in any way nor any of his case is pending in his court. He has, therefore, requested that the Hon'ble Court may be pleased to grant him permission for sale of car to the proposed purchaser.

In this connection, it is submitted that the officer has joined the U.P. Judicial Services on 08.01.2021 and the aforementioned car is stated to have been purchased by the officer in the year 2019 i.e. before joining of judicial service. The relevant Rule 24(2) of the U.P. Government Servant's Conduct Rules-1956, applicable in this case, is reproduced as below: -

"A Government servant who enters into any such transaction concerning any movable property exceeding in value the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority.

Provided that no Government servant shall enter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Ajai kumar Srivastava-I, Administrative Judge, Ambedkar Nagar at Akbarpur also nominated for "Disposal of the matters of the Judicial officers wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956", for the district Ambedkar Nagar, for His Lordship's kind perusal and, if His Lordship approves, Sri Rajan Rathee, Judicial Magistrate, Ambedkar Nagar at Akbarpur be granted permission to sell his old Hyundai I20 car, bearing reg. No. HR12 AK2520 to one Sri Ravinder Kumar R/o House no 232, Housing board colony, Sector 23, Sonipat, Haryana for Rs. 3,00,000/-, as requested, subject to the condition that the relevant papers in connection with the sale transaction shall be furnished by him immediately on completion of the transaction?
