May kindly see the online application of Sushri Swati Verma II, Civil Judge (Junior Division), Bareilly who has joined her service on 26.06.2020, drawing gross salary of Rs. 1,23,549/- & take home salary of Rs. 1,01,269/- regarding information about purchase of a new Maruti Suzuki S Cross Smart Hybrid Zeta model, allotted reg. no. UP21 CS8948 (copy of RC can be seen as attachment namely- Registration Certificate), intimated through application dated 29.11.2023.

Through her application, Sushri Swati Verma II has submitted information about purchase of a new Maruti Suzuki S-Cross Smart Hybrid Zeta model on 29.05.2022 by giving point wise details as per Court's C.L. no. 25/Admin(A) dated 13.07.1998, according to which the car has been purchased by her from Akanksha Automobiles Pvt. Ltd. Authorised dealer for Maruti Suzuki India Ltd. Moradabad, Uttar Pradesh who is an authorized dealer, for Rs. 11,24,000/- (copy of invoice can be seen as attachment namely- Scross Invoice), source of money of which is that Rs. 9,80,000/- has been taken as loan from Punjab National Bank, Ekta Nagar Branch, Bareilly repayable in 84 monthly EMIs of Rs. 14,866/- (copy of loan arrangement letter can be seen as attachment namely- Loan Sanction Letter), Rs. 1,33,000/- is stated to have been paid in cash by her father (copy of 'Consent letter' and 'receipt' can be seen as attachment namely- Consent/Gift Letter and Cash Invoice), Rs. 11,000/- is stated to have been paid in cash as booking amount. The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Bareilly for His Lordship's kind perusal and information under Rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
