May kindly see the online application of Sri Ratn Shekhar Nirmal, Civil Judge (Junior Division), Saharanpur who joined service on 15.11.2019, drawing gross salary of Rs. 1,08,085/- & take home salary of Rs. 91,252/- regarding information about purchase of a new Maruti Grand Vitara Delta CNG 1.5L, allotted reg. no. UP73 AD2087 (Copy of RC can be seen as attachment namely- Annex E Registration certificate car), intimated through application dated 01.12.2023.

Through his application, Sri Ratn Shekhar Nirmal, has submitted information about purchase of a new car on 16.06.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Bright 4-Wheel Sales Pvt. Ltd., Lucknow for Rs. 15,37,595/- in total (Copy of Sale invoice can be seen as attachment namely- Annex A car invoice), source of money of which is that Rs. 13,00,000/- has been taken as loan from State Bank of India, Allahabad, repayable in 84 monthly EMIs of Rs. 21,000/- (copy of 'loan account statement' can be seen as attachment namely- Annex D loan account statement), Rs. 2,26,595/- (Rs.50,000/- Rs. 1,00,000/- Rs. 76,595/-) is stated to have been paid out of his saving bank account (copy of statement of A/c can be seen as attachment namely- Annex C e-passbook Bank statement), Rs. 11,000/- is stated to have been paid as advance through UPI (copy of receipt can be seen as attachment namely- Annex B payments made advance and by loan). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Saharanpur also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Saharanpur for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
