May kindly see the online application of Sri Mahendra Kumar Rawat, A.D.J., F.T.C., Hathras regarding grant of permission to purchase 0.32" Pistol".

In his application, Sri Rawat has stated that he has not been provided personal security by the Police. He has to travel to various places as well as native place without security. At present, he is posted in Hathras District, which is a remote area and due to the nature of his work, he needs permission to purchase a firearm. He has obtained a firearm license from the District Magistrate Jalaun at Orai (Copy of firearm license is in attachment). He also obtained a quotation from 'Lucknow Arms Corporation' Meston Road Kanpur, who is a registered dealer of firearms. The cost of a firearm (32-bore pistol by Webley & Scott, quotation is in attachment) is approximately Rs. 1,10,000/- to 1,40,000/- which is payable from his salary Account no. 31000364875 SBI Lucknow in which he has sufficient amount. He has, therefore, most humbly requested to permit him to purchase the firearm.

In this connection, it is submitted that according to this Court's C.L. no. 11/ IVh-16/ Admin (A) dated 12.04.2010, the officer is required to take permission from this Court to purchase a firearm, for which he has requested. His request is considerable, as he has submitted sufficient details of the proposed transaction. The pistol appears to be costing Rs. 1,10,000/- to Rs. 1,40,000/- which is less than one month's of his basic pay. The basic pay of the officers of A.D.J. cadre starts from Rs. 1,44,840/- at present. He has already stated that he has sufficient amount in his savings bank account.

May therefore, if approved, the matter be laid before Hon'ble Mr. Justice Ashutosh Srivastava, Administrative Judge, Hathras, also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Hathras, for His Lordship's kind perusal and if His Lordship approves, Sri Mahendra Kumar Rawat, A.D.J., F.T.C., Hathras be granted permission to purchase 32-bore pistol by Webley & Scott from 'Lucknow Arms Corporation' Meston Road Kanpur within the price range of Rs.1,10,000/- to Rs. 1,40,000/-, as requested, subject to the conditions that relevant papers of purchase transaction be submitted by him immediately after its completion?
