May kindly see the online application/ request no. S000380642023 dated 07.12.2023 of Sri Piyush Moolchandani, Civil Judge(Junior Division), Kasganj whereby he has requested for inclusion of his LL.M. qualification in his service records.

Sri Piyush Moolchandani, in his application, has submitted that he has been granted prior permission from this Hon'ble Court vide this Court's letter no. 3875/IV-4925/Admin(A-4) dated 07.03.2020 to pursue the aforesaid LL.M. Course from Kurukshetra University, Haryana and he successfully pursued LL.M. distance learning course/program in the year 2022 from Kurukshetra University, Haryana and would like to add this educational achievement in his Service Record. He has, therefore, requested for addition of LL.M. Degree in Service Record.

An objection dated 31.01.2024 was raised by this office asking him for clarification regarding recognition of the Kurukshetra University, Kurukshetra, Haryana by UGC and approval of the aforesaid course & in reply, he has furnished the university documents by attachment dated 24.03.2024.

In support of the same, Sri Piyush Moolchandani has furnished the copy of permission letter of this Court regarding grant of earlier permission(at attachment Sl. no. 1) and his LL.M. credentials comprising attested copies of Mark-sheets of both the years (at attachment nos. 2-3) and degree (at attachment sl. no. 4). by attachment dated 07.12.2023 as well as copies of recognition-related papers of the University (at attachment sl no. 5).

In this context, it is submitted that Sri Piyush Moolchandani, aforesaid joined the U.P. Judicial Service on 18.11.2019 as Additional Civil Judge(Junior Division), Budaun. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the examination year May 2022 for LL.M. Pre date of result 09.02.2022 & LL.M. II final year's date of result 10.12.2022 as endorsed on marksheets.

Further, it is submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Piyush Moolchandani, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/ request dated 07.12.2023 of Sri Piyush Moolchandani, Civil Judge(Junior Division), Kasganj may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Siddharth, Administrative Judge, Kasganj for His Lordship's kind perusal and if His Lordship approves, a copy of online application/ request dated 07.12.2023 of Sri Piyush Moolchandani, Civil Judge(Junior Division), Kasganj along with copies of, Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of his form of U.P. Judicial Service,

may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in his service records?
