Provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad, for His Lordship's kind perusal and if His Lordship approves, permission be accorded to Sri Rajeev Ranjan Mishra, Civil Judge (Junior Division), Ghaziabad to sell his immovable property i.e. land measuring 0.025 acre, being portion of present survey Plot No. 1281, recorded under Khata no. 210, situated at Dimna, East Singhbhum, Jharkhand to Sri Sanjay Kumar Singh, Mango, Jamshedpur Dist - East Singhbhum, Jharkhand for Rs. 18,00,000/-, as requested, subject to the conditions that he should submit the relevant papers of the transaction after its completion?
