May kindly see online requisition dated 15.12.2023 of Sushri Sonam Gautam, Civil Judge (Junior Division), Mathura, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 38332023. In this regard, Sushri Sonam Gautam, has furnished her duly attested scanned copies of LL.M. Mark-sheets (all semesters as well as Consolidated) and of the Degree Qualification, as supporting documents for the same.

In the context, it is submitted that Sushri Sonam Gautam, joined the U.P. Judicial Service on 16.12.2019, initially as Additional Civil Judge(Junior Division), Gonda. Further, it is relevant to mention here that Sushri Sonam Gautam, pursued her LL.M. course for the session 2017-2019, from University of Allahabad, Allahabad prior to Joining the Judicial Service. Additionally, she has mentioned in her application that she was in the middle of the course at the time of filling her application form and also the result was awaited and therefore she could not mention about it at any stage of the examination.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (all semesters) and copy of the Degree Qualification, Sushri Sonam Gautam, completed her two-year LL.M. degree course on 18.06.2019 and was subsequently awarded Degree from University of Allahabad, Allahabad on 26.02.2021, thus the said qualification may be included in her service records, as is prayed for. In her application, she has mentioned that "There are two dates mentioned on the degree. The two dates mentioned in the Degree Certificate i.e. 26.02.2021 and 13.12.2021 are mentioned for different reasons as informed by the concerned department of the University of Allahabad. Firstly, 26.02.2021 is the date when the Executive Council of University of Allahabad had fixed the date of issuance of Degree Certificates to the Graduates/ Post- graduates candidates of the Session 2018-2019. Secondly, 13.12.2021 is the date when the candidate (the applicant in the present situation) has applied for the issuance of his Degree Certificate".

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sushri Sonam Gautam, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 15.12.2023 of Sushri Sonam Gautam, Civil Judge(Junior Division), Mathura to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura, for His Lordship's kind perusal and order to the effect that a copy of her online requisition along with the copy of mark-sheets (four semesters as well as consolidated) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sushri Sonam Gautam, Civil Judge(Junior Division), Mathura, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
