The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

It is noteworthy to mention here that the officer has received an amount of Rs. 50,000 from his father as a gift (copy of 'consent letter' and his father's saving bank A/c can be seen as attachment)
