May kindly see the online application of Sri Abhishek Tripathi- I, Civil Judge (Senior Division), Barabanki who joined service on 11.01.2017, drawing gross salary of Rs. 1,97,757/- & take home salary of Rs. 1,42,536/- regarding information about purchase of a new Honda Elevate ZX CVT (I-VTEC), allotted reg. no. UP32 NZ6737 (Copy of RC can be seen as attachment namely- Registration Paper), intimated through application dated 21.12.2023.

Through his application, Sri Abhishek Tripathi- I has submitted information about purchase of a new car on 22.10.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from MG Auto Sales Pvt. Ltd., Lucknow for Rs. 18,56,000/- in total (Copy of Tax invoice can be seen as attachment namely- tax invoice), source of money of which is that Rs. 16,00,000/- has been taken as loan from State Bank of India, repayable in 84 monthly EMIs of Rs. 25,946/- (copy of 'loan arrangement letter' can be seen as attachment namely- loan paper), Rs. 1,96,000/- (Rs. 1,75,000/- Rs. 21,000/-) is stated to have been paid out of his saving account (copy of statement of his A/c can be seen as attachment namely- Online bank statement), Rs. 60,000/- is stated to have been paid in exchange of his old car (copy of RC as well as Delivery Receipt can be seen as attachment namely- RC of UP 53 AL 9011 and Purchase Agreement Old Car). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Barabanki for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
