May kindly see the online application/ request vide case id 00052024 dated 01.01.2024 of Sri Sandeep Gupta II, Additional District & Sessions Judge, Moradabad whereby he has requested for inclusion of his LL.M. qualification in his service records.

In support of the same, Sri Sandeep Gupta II has furnished copies of recognition-related papers of the University (from attachment sl. no. 3 & 5), copy of online permission letter of this Court regarding grant of earlier permission (attachment sl. no. 4) by attachment dated 29.01.2024 and his LL.M. credentials comprising attested copies of Mark-sheets of both the years(at attachment sl. no. 1-2) and degree (at attachment sl. no. 6).

Several objections dated 03.01.2024 & 05.03.2024 were raised by this office with regard to requisite documents and necessary clarification & in reply, thereto, he has furnished the desired documents/clarification by response dated 29.01.2024 & 05.03.2024 respectively.

In this context, it is submitted that Sri Sandeep Gupta II, aforesaid joined the U.P. Judicial Service on 29.07.2019 as Additional District Judge(FTC), Muzaffar Nagar. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 29.12.2023 for the examination year May 2023 for LL.M. II (final year) marksheet issued on 21.11.2023 as well as for 1st year issued on 10.12.2022. He has persued the aforesaid LL.M. Course with the prior permission of this Court and copy of the same has been furnished by attachment dated 29.01.2024 at sl. no. 4.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Sandeep Gupta II, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/request dated 01.01.2024 of Sri Sandeep Gupta II, Additional District & Sessions Judge, Moradabad may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Moradabad for His Lordship's kind perusal and if His Lordship approves, a copy of online application/request dated 01.01.2024 of Sri Sandeep Gupta II, Additional District & Sessions Judge, Moradabad along with copies of, Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of his form of U.P. Higher Judicial Service, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in his service records?
