May kindly see the online application of Sri Anurag Yadav, Additional Civil Judge (Sr. Division)/ACJM., Jhansi, who joined service on 13.06.2018, drawing gross salary of Rs. 1,42,790/- & take home salary of Rs. 1,03,586/- regarding information about purchase of a new Tata Safari Accomplished DT car, allotted reg. no. UP70GV8686, intimated through application dated 05.01.2024.

Through his application, Sri Anurag Yadav, has submitted information about purchase of a new car on 14.12.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from JMK Motors Pvt. Ltd., Janki puram, Civil Lines, Jhansi, U.P. for Rs. 27,50,000/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 17,00,000/- has been taken as loan from SBI, Jhansi, repayable in 84 EMIs of Rs. 27,568/- (copy of 'loan arrangement letter' can be seen as attachment), Rs. 50,000/- is stated to have been paid by SBI debit card as booking amount, 5,00,000/- as down payment through cheque no. 719317 out of his S.B. A/c (copy of statement of A/c can be seen as attachment) & Rs. 5,00,000/- is stated to have been paid by his father to the dealer as interest free loan through cheque no. 746094 out of his S.B. A/c (copy of 'consent letter of his father can be seen as attachment). It is pertinent to mention here that the permission to accept gift money from his father of Rs. 5,00,000/- has already been sent by the officer vide (Case ID no. S00030402023). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Jhansi also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Jhansi for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
