May kindly see the online application of Sri Harvir Singh, District & Sessions Judge, Firozabad who joined service on 15.12.2008, drawing gross salary of Rs. 3,22,622/- & take home salary of Rs. 2,29,400/- regarding information about purchase of a new Skoda Slavia Car, allotted reg. no. 24BH 1512A (Copy of RC can be seen as attachment namely- purchase of vehicle SKODA SLAVIA AMBITION, page no. 5), intimated through application dated 11.01.2024. Through his application, Sri Harvir Singh has submitted information about purchase of a new car on 19.12.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Sidak Automobiles Pvt. Ltd., Haryana, for Rs. 14,67,773/- in total (Copy of invoice can be seen as attachment namely- Invoice of SKODA Car), source of money of which is that Rs. 11,00,000/- has been taken as loan from SBI, repayable in 60 monthly EMIs of Rs. 22,357/-(copy of 'loan arrangement letter' can be seen as attachment namely- purchase of vehicle SKODA SLAVIA AMBITION, page no. 4), Rs. 3,40,000/- (on 13.12.2023) is stated to have been paid out of his saving bank account (copy of statement of A/c can be seen as attachment namely- purchase of vehicle SKODA SLAVIA AMBITION, page no. 7), Rs. 17,773/- is stated to have been paid via UPI (copy of Receipt can be seen as attachment namely- purchase of vehicle SKODA SLAVIA AMBITION, page no. 8), Rs. 10,000/- is stated to have been paid as advance (copy of receipt can be seen as attachment namely- Receipt of ten thousand). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court. Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Firozabad for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
