May kindly see the online application of Sri Rajneesh Mohan Verma, Judge, Spl. Court, CBI Court No. 4, Lucknow who joined service on 07.05.2009, drawing gross salary of Rs. 2,19,913/- & take home salary of Rs. 1,68,946/- regarding information about purchase of a new Tata Nexon Fearless plus S Amt Dt 1.5 car, allotted reg. no. UP32 NY8008 (Copy of RC can be seen as attachment namely-Registration certificate), intimated through application dated 17.01.2024.

Through his application, Sri Rajneesh Mohan Verma has submitted information about purchase of a new car on 26.10.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from SRM Motors Pvt. Ltd., Lucknow for Rs. 17,68,000/in total (Copy of Tax invoice can be seen as attachment namely- insurance and Invoice part 1), source of money of which is that Rs. 8,00,000/- has been taken as loan from Punjab National Bank, repayable in 84 monthly EMIs of Rs. 12,864/-(copy of 'loan arrangement letter' can be seen as attachments namely- Bank loan), Rs. 50,000/- is stated to have been paid through cheque (copy of 'cheque' can be seen as attachment namely- booking cheque), Rs. 9,18,000 is stated to have been paid out of his saving bank account(copy of statement of A/c can be seen as attachment namely- RTGS from My Account). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

About the source of money, the officer has additionally submitted that in addition to his regular income from my salary, the arrears of salary are paid to him in compliance with the order of Hon,ble Supreme Court of India accepting the recommendation of SNJPC. The arrears of salary of his service in the cadre of junior division is Rs.415999/- out of which he got Rs. 249599/- after all deductions. Arrears of salary of his service in the cadre of senior division and HJS is Rs. 1068099/- out of which he got Rs. 645055/- after all deductions. The total Net Amount of Rs 894654 (eight lacks ninety-four thousand six hundred fifty-four Rupees ), after all, deductions were received by him as arrears of salary in compliance with the order of Hon,ble Supreme Court of India,( details of the Arrears bills are attached herewith).

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Lucknow, for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
