May kindly see the online requisition dated 19.01.2024 of Smt. Harkiran Kaur, Additional Chief Judicial Magistrate, Bhadohi at Gyanpur for inclusion of Ph.D. Degree in her service records. In view of the above, Smt. Harkiran Kaur has furnished the duly scanned & attested copy of Degree Qualification as well as copy of ex-post-facto permission letter of this Hon'ble Court to pursue the aforesaid course, as supporting documents for the same.

An objection dated 29.03.2024 was raised by this office to furnish the clearly scanned and duly attested copy of Ph.D. degree qualification and permission letter of Hon'ble Court to pursue the Ph.D. degree. In reply thereto, Smt. Harkiran Kaur, aforesaid has furnished the copy of desired documents hereon by attachment dated 05.04.2024 at under the heading of 'Verified copy of Ph.D. degree' & 'Permission Letter'.

In this connection, it is submitted that Smt. Harkiran Kaur, joined U.P. Judicial Services on 16.01.2017 as Judicial Magistrate, Ramabai Nagar. Besides, as evident from submitted copy of degree of Ph.D., Smt. Harkiran Kaur was awarded the degree of Doctor of Philosophy (Ph.D.) on 11.11.2019 for the year 2018 from the department of Law of Babasaheb Bhimrao Ambedkar University, Lucknow on the topic "Biopiracy in Intellectual Property Rights Regime: A Legal Study with Special Reference to the Rights of Indigenous People" after her joining the U.P. Judicial Services, with due permission of this Hon'ble Court to appear in the Viva-voce examination of the aforesaid course.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of Ph.D. degree may be included in her service-records of Smt. Harkiran Kaur, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems appropriate that aforesaid online application dated 19.01.2024 of Smt. Harkiran Kaur, Additional Chief Judicial Magistrate, Bhadohi at Gyanpur may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, If approved, the matter may kindly be placed before Hon'ble Mr. Justice Mohd. Azhar Husain Idrisi, Administrative Judge, Bhadohi at Gyanpur, for His Lordship's kind perusal and approval to the effect that a copy of aforesaid online application dated 19.01.2024 along with attested copy of Ph.D. degree as well as attested copy of form of U.P. Nyayik Sewa of Smt. Harkiran Kaur, Additional Chief Judicial Magistrate, Bhadohi at Gyanpur may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders in the instant matter ?
