May kindly see the online application of Sri Vijay Kumar Dungrakoti, Additional District & Sessions Judge, Pilibhit who joined service on 08.01.2004, drawing gross salary of Rs. 2,88,604/- & take home salary of Rs. 2,12,204/- regarding information about purchase of a new Mahindra Scorpio N car, allotted reg. no. UP26 AS1185 (Copy of RC can be seen as attachment namely- Documents related to purchase of new CAR, page no. 3) intimated through application dated 25.01.2024.

Through his application, Sri Vijay Kumar Dungrakoti has submitted information about purchase of a new car on 17.12.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Mosaram Enterprises Ltd., L.R.P. Chauraha, Lakhimpur, for Rs. 24,00,000/- in total (Copy of Tax invoice can be seen as attachment namely- Documents related to purchase of new CAR, page no. 5), source of money of which is that Rs. 6,00,000/- has been taken as loan from State Bank of India, Pilibhit, repayable in 60 monthly EMIs of Rs. 12,499/- (copy of 'loan arrangement letter' can be seen as attachment namely- Documents related to purchase of new CAR, page no. 7-8), Rs. 18,00,000/- (Rs. 10,00,000/- Rs. 8,00,000) is stated to have been paid out of his saving bank account (copy of statement of A/c can be seen as attachment namely- Attested copy of passbook). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

It is pertinent to mention here that the officer has sold his old Tata Safari car bearing registration no. UP14 BZ2133 (copy of RC of his old car can be seen as attachment namely- RC copy of old car) to Mosaram Enterprises Limited (Regular and Reputed one) for Rs. 2,20,000/- (Copy of Delivery Certificate can be seen as attachment namely- Documents related to purchase of new CAR, page no. 9)

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Pilibhit also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Pilibhit for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
