May kindly see the online application of Smt. Chetna Tyagi, Additional Civil Judge (Senior Division), Sant Kabir Nagar, who has joined her service on 07.09.2018, drawing gross salary of Rs. 1,65,610/- & take home salary of Rs. 1,29,004/- regarding information about purchase of a new Mahindra Bolero car, allotted reg. no. UP30 BS5001 (copy of RC can be seen as attachment namely- Registration Certificate), intimated through application dated 29.01.2024.

Through her application, Smt. Chetna Tyagi has submitted information about purchase of a new Mahindra Bolero car on 24.12.2023 by giving point wise details as per Court's C.L. no. 25/Admin(A) dated 13.07.1998, according to which the car has been purchased by her from Narain Automobiles, Hardoi, who is an authorized dealer, for Rs. 12,45,000/- (copy of invoice can be seen as attachment namely- Invoice), source of money of which is that Rs. 8,00,000/- is stated to have been taken as loan from SBI, Hardoi, repayable in 60 monthly EMIs of Rs. 16,568/- (Copy of Loan arrangement letter can be seen as attachment namely- Loan arrangement letter), Rs. 4,45,000/- (Rs. 5,000/- on 13.12.2023 Rs. 40,000/- on 23.12.2023 Rs. 60,000/- on 23.12.2023 Rs. 3,40,000/- on 27.12.2023) is stated to have been paid out of her SBI Bank A/c (copy of SBI A/c with index page can be seen as attachment namely- Bank Statement ). The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Shiv Shanker Prasad, Administrative Judge, Sant Kabir Nagar also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Sant Kabir Nagar for His Lordship's kind perusal and information under Rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
