May kindly see the online application/request vide case id no. 39352024 dated 02.02.2024 of Sri Rajat Sinha, Spl. Judge (SC/ST Pre of Atroci Act), Ramabai Nagar whereby he has requested for inclusion of his Post Graduate Diploma qualification in his service records.

Sri Rajat Sinha, in his application, has submitted that, he has pursued one year Post Graduate Diploma in Medical Law & Ethics from National Law School of India University, Bengaluru after obtaining prior permission of this Court for pursuing the aforesaid course, copy of online permission letter has been furnished by attachment dated 02.02.2024 at sl.no. 2 and would like to add this educational achievement in his Service Record. He has, therefore, requested for addition of LL.M. Degree in Service Record. In support of the same, Sri Rajat Sinha, has furnished his aforesaid degree credentials comprising attested copy of Original Transcript/Grade Sheet dated 26.08.2023 and degree dated 26.08.2023 (attachment sl. no. 1). In this context, it is submitted that Sri Rajat Sinha, aforesaid joined the U.P. Judicial Service on 22.12.2003 Additional Civil Judge (Junior Division), Ramabai Nagar. Besides, as evident from submitted attested copy of Grade-sheet and the Degree qualification of Post Graduate Diploma Qualification, he has completed one year Post Graduate Diploma in Medical Law & Ethics for the period July-2022 to June-2023 and was subsequently awarded Degree from National Law School of India University, Bengaluru.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of Post Graduate Diploma in Medical Law & Ethics from National Law School of India University, Bengaluru may be included in the service records of Sri Rajat Sinha, aforesaid with the order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/request dated 02.02.2024 of Sri Rajat Sinha, Spl. Judge (SC/ST Pre of Atroci Act), Ramabai Nagar may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Ramabai Nagar for His Lordship's kind perusal and if His Lordship approves, a copy of online application/request dated 02.02.2024 of Sri Rajat Sinha, Spl. Judge (SC/ST Pre of Atroci Act), Ramabai Nagar, along with copy of Original Transcript/Grade Sheet and of degree, as well as attested copy of his form of U.P. Nyayik Sewa, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of Post Graduate Diploma Qualification in his service records?
