May Kindly see the online application of Sushri Charu Kain, Addl. Civil Judge (Junior Division), Banda by which she has requested for grant of permission to appear in the Mains examination of Delhi Judicial Services Examination 2023.

In her application, Sushri Charu Kain has stated that she has applied for Delhi Judicial Service Examination 2023 and also sought permission of the Hon'ble High Court to appear in the said examination. In anticipation of the said permission, she has appeared in the Delhi Judicial Services Preliminary Examination 2023 and has also cleared the said preliminary examination. She has further stated that now she wants permission to appear in the Delhi Judicial service Mains Examination 2023 (Copy of result can be seen under attachment heading "Result Preliminary examination"). She has, therefore, requested to Hon'ble Court to grant her permission to appear in the aforesaid Mains examination of Delhi Judicial Services Examination 2023.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 16.11.2019. It is also pertinent to mention here that the officer has applied for grant of permission to appear in the preliminary examination of Delhi Judicial Services Examination, 2023 through online case Id. S00037012023 and the same has been granted vide order dated 01.03.2024 of Hon'ble Administrative Judge, Banda. Now as the officer is seeking for grant of permission to appear in the Mains examination of the Delhi Judicial Services exam 2023 as she has cleared the prelims exam for which she has earlier sought permission. It is also to mention here that from the perusal of other application of the same matter, it appears that the date of Mains exam of DJS 2023 has been rescheduled to 13.04.2024 to 14.04.2024. Now, it is on the discretion of His Lordship either to grant her permission to appear in the Mains Examination of the same as she has cleared the preliminary examination or to pass any other order. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Krishan Pahal, Administrative Judge, Banda for His Lordship's kind perusal and orders to the effect that permission be accorded to Sushri Charu Kain, Addl. Civil Judge (Junior Division), Banda to appear in the Mains examination of Delhi Judicial Services Examination 2023, as requested, subject to the conditions mentioned above?
