May Kindly see the online application of Sushri Shilpa Jain, Civil Judge (Junior Division) (FTC), Bijnor by which she has requested for grant of permission to appear in the Mains examination of Delhi Judicial Services Examination 2023.

In her application, Sushri Shilpa Jain has stated that vide online case ID S00037172023 she has sought permission to participate in the preliminary examination of Delhi Judicial Services examination and in anticipation of approval from the Hon'ble Court she has appeared in the same and also successfully cleared the preliminary round (Copy of result can be seen under attachment heading "Annexure"). She has also assured that she would not avail any study leaves for the purpose of examination and if the permission is granted, it would not disrupt her Court work. She has, therefore, requested to Hon'ble Court to grant her permission to appear in the aforesaid Mains examination of Delhi Judicial Services Examination 2023.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 15.11.2019. It is also pertinent to mention here that the officer has applied for grant of permission to appear in the preliminary examination of Delhi Judicial Services Examination, 2023 through online case Id. S00037172023 and the same is at the level of Hon'ble Administrative Judge, Bijnor. Now as the officer is seeking for grant of permission to appear in the Mains examination of the Delhi Judicial Services exam 2023 as she has cleared the prelims exam for which she has earlier sought permission. It is also to mention here that from the perusal of other application of the same matter, it appears that the date of Mains exam of DJS 2023 has been rescheduled to 13.04.2024 to 14.04.2024. Now, it is on the discretion of His Lordship either to grant her permission to appear in the Mains Examination of the same as she has cleared the preliminary examination or to pass any other order. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

- 1. Government work should not suffer in any way.
- 2. No preferential treatment will be given in the matter of leave, postings and transfer.
- 3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Bijnor for His Lordship's kind perusal and orders to the effect that permission be accorded to Sushri Shilpa Jain, Civil Judge (Junior Division) (FTC), Bijnor to appear in the Mains examination of Delhi Judicial Services Examination 2023, as requested, subject to the conditions mentioned above?
