May kindly see the online application/request dated 06.02.2024 vide case id no. 39522024 of Sri Ram Mani Pathak, the then Additional Principal Judge, Family Court, Sitapur, presently posted as Spl. Judge (SC/ST, Pre. of Atroci Act), Chitrakoot whereby he has requested for inclusion of his LL.M. qualification in his service records

Sri Ram Mani Pathak, in his application, has submitted that vide Court's Letter No. 9768/IV-3612/Admin. (A-4) Dated: 18/08/2021 (attachment S.No.1), he has been granted permission to do/pursue LL.M. Course through Kurukshetra University, Haryana and he successfully pursued LL.M. distance learning course/program in May, 2023 from Kurukshetra University, Haryana and would like to add this educational achievement in his Service Record. He has, therefore, requested for addition of LL.M. Degree in Service Record.

In support of the same, Sri Ram Mani Pathak, has furnished copies of recognition-related papers of the University (from attachment sl. nos. 5-7), copy of permission letter of this Court regarding grant of earlier permission (attachment sl. no. 1) and his LL.M. credentials comprising attested copies of Mark-sheets of both the years (attachments. no. 2 & 3) and degree (attachment sl. no. 8).

An objection dated 21.02.2024 was raised by this office to furnish the clearly scanned and attested copy of LL.M Degree Qualification, & in reply thereto, he has furnished the copy of desired document by attachment dated 27.02.2024.

In this context, it is submitted that Sri Ram Mani Pathak, aforesaid joined the U.P. Judicial Service on 20.04.2009 as Additional Civil Judge (Junior Division), Deoria. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.01.2024 for the examination year May 2023.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Ram Mani Pathak, aforesaid with the order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/request dated 06.02.2024 of Sri Ram Mani Pathak, the then Additional Principal Judge, Family Court, Sitapur, presently posted as Spl. Judge (SC/ST, Pre. of Atroci Act), Chitrakoot may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Syed Qamar Hasan Rizvi, Administrative Judge, Chitrakoot for His Lordship's kind perusal and if His Lordship approves, a copy of online application/request dated 06.02.2024 of Sri Ram Mani Pathak, the then Additional Principal Judge, Family Court, Sitapur, presently posted as Spl. Judge (SC/ST, Pre. of Atroci Act), Chitrakoot along with copies of, Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of his form of U.P. Nyayik Sewa, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the

Government of U.P. relating to inclusion of LL.M. degree in his service records?
