May kindly see the online application/ request no. S00039542024 dated 09.02.2024 of Smt. Ekta Singh-I, Additional Principal Judge(Family Court), Ayodhya whereby she has requested for inclusion of her LL.M. qualification in her service records.

Smt. Ekta Singh-I, in her application, has submitted that she has been granted permission from this Hon'ble Court to pursue the aforesaid LL.M. Course from Kurukshetra University, Haryana and she successfully pursued LL.M. distance learning course/program in the year 2023 from Kurukshetra University, Haryana and would like to add this educational achievement in her Service Record. She has, therefore, requested for addition of LL.M. Degree in Service Record.

In support of the same, Smt. Ekta Singh-I has furnished copies of recognition-related papers of the University, copy of permission letter of this Court regarding grant of earlier permission and her LL.M. credentials comprising attested copies of Mark-sheets of both the years by attachment dated 06.02.2024 at sl. no. 1. and degree by attachment dated 06.03.2024 at sl. no. 1.

In this context, it is submitted that Smt. Ekta Singh-I, aforesaid joined the U.P. Judicial Service on 27.04.2009 as Additional Civil Judge(Junior Division), Barabanki. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., she has completed two year LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.01.2024 for the examination year Dec, 2022 for 1st year marksheet result dated 09.02.2022 as well as for LL.M. II (final years) result dated 22.03.2023.

Further, it is submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Smt. Ekta Singh-I, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/ request dated 09.02.2024 of Smt. Ekta Singh-I, Additional Principal Judge(Family Court), Ayodhya may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Ayodhya for His Lordship's kind perusal and if His Lordship approves, a copy of online application/ request dated 09.02.2024 of Smt. Ekta Singh-I, Additional Principal Judge(Family Court), Ayodhya along with copies of, Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of her form of U.P. Judicial Service, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in her service records?
