

**Registrar (J)(Budget)**

May kindly see the online application/ request dated 14.02.2024 of Sri Sandeep Chaudhary, Joint Registrar (Judicial), High Court, Allahabad, posted on deputation, whereby he has requested for inclusion of his LL.M. qualification in his service records.

Sri Sandeep Chaudhary, in his application, has submitted that vide Court's Letter No. 18014/IV-3637/Admin. (A-4) Dated: 09/12/2019, he has been granted permission to take admission and pursue LL.M. Course through Kurukshetra University, Haryana and he successfully pursued LL.M. distance learning course/program in May, 2023 from Kurukshetra University, Haryana and would like to add this educational achievement in his Service Record. He has, therefore, requested for addition of LL.M. Degree in Service Record.

In support of the same, Sri Sandeep Chaudhary has furnished copies of recognition-related papers of the University (from attachment sl. no. 1-3), copy of permission letter of this Court regarding grant of earlier permission (attachment sl. no. 4) and his LL.M. credentials comprising attested copies of Mark-sheets of both the years and degree (from attachment sl. no. 5-7).

In this context, it is submitted that Sri Sandeep Chaudhary, aforesaid joined the U.P. Judicial Service on 20.04.2009. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 29.12.2023 for the examination year May 2023 for LL.M. II (final years) as well as for 1st & 2nd year's back paper, whose examination was carried out in the same span of time by the University and due to which, there's a common date of result (i.e. Nov. 21, 2023) and Mark-sheets issuance date i.e. 12th December, 2023.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Sandeep Chaudhary, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/request dated 14.02.2024 of Sri Sandeep Chaudhary, Joint Registrar (Judicial), High Court, Allahabad may be sent to the Government of U.P. for obtaining necessary orders in this regard.

It is also noteworthy to mention here that normally such type of matters are submitted to Hon'ble the Administrative Judges concerned but as the officer is posted in this Hon'ble Court as Joint Registrar (Judicial), High Court, Allahabad, as per resolution passed in the meeting of the Hon'ble Administrative Committee held on 12.07.2013, he is under the exclusive control of the Hon'ble The Chief Justice and as such, his instant matter is likely to be placed before Hon'ble The Chief Justice.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble the Chief Justice for His Lordship's kind perusal and if His Lordship approves, a copy of online application/request dated 14.02.2024 of Sri Sandeep Chaudhary, Joint Registrar (Judicial), High Court, Allahabad, along with copies of, Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of his form of U.P. Nyayik Sewa, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in his service records?
