May kindly see the online application of Sri Vinayak Somvanshi, Nyayadhikari, Gram Nyayalaya, Baraut-Baghpat, who joined service on 19.12.2019, drawing gross salary of Rs. 1,23,549/- & take home salary of Rs. 1,01,269/- regarding information about purchase of a new Mahindra XUV 700, allotted reg. no. UP17 Y8004 (Copy of RC can be seen as attachment namely- docs related to purchase of new car as per C.L. no.25/admin[A] dated 13 July 1998, page no. 4), intimated through application dated 14.02.2024.

In his application, Sri Vinayak Somvanshi has submitted information about purchase of a new car on 15.10.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from A to Z Auto Wheels Pvt. Ltd., Meerut Road, Muzaffarnagar, for Rs. 21,30,000/- in total (Copy of invoice can be seen as attachment namely- docs related to purchase of new car as per C.L. no.25/admin[A] dated 13 July 1998, page no. 6), source of money of which is that Rs. 18,10,000/- is stated to have been taken as loan from SBI, repayable in 84 Monthly EMIs of Rs. 29,030/- (Copy of 'loan arrangement letter can be seen as attachments namely- legible copy of key fact statement of loan and legible copy of loan statement showing EMI), Rs. 3,20,000/- (Rs. 50,000/- Rs. 2,70,000/-) is stated to have been paid out of his saving account (copy of statement of his A/c can be seen as attachment namely- docs related to purchase of new car as per C.L. no.25/admin[A] dated 13 July 1998, page 17-24). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Baghpat for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
