May kindly see the online application of Sri Manjeet Singh Sheoran, Presiding Officer, Motor Accident Claims Tribunal, Ghaziabad regarding information about sale of his old Toyota Innova car, intimated through his application dated 15.02.2024.

In his application, Sri Manjeet Singh Sheoran has stated that he purchased Toyota Innova car (Diesel), bearing registration number HR20 AA4804 in June 2013 from Malik Automotives Pvt. Ltd. (Regular and Reputed one)(copy of RC can be seen as attachment) . After 10 years, Diesel car could not be operated in NCR. So, he has decided to sell it off. Thus, on 13.07.2023, he has sold his car to J.S Security and Placement service, Hisar through Malik Toyota Authorised Dealer (Regular and Reputed). The sale price of the said vehicle i.e. Rs. 4,50,000/- (copy of delivery receipt and valuation sheet can be seen as attachment), and the same amount was transferred to his account by J.S Security and Placement service (copy of statement of A/c can be seen as attachment). The officer has therefore, intimated about the sale of his old car for kind perusal of this Hon'ble Court.

It is pertinent to mention here that the officer has stated that his car was purchased by J.S Security and Placement service, Hisar. The officer's brother (Avtar Singh) and his brother's wife (Seema Sheoran) are partners in the above mentioned firm. It is further stated that his younger brother Avtar Singh and his brother's wife are not dependent on him in any manner and they don't fall under the definition of family as provided in Section 2 (c) of The U.P. Government Servant's Conduct Rules, 1956. He further submitted that any case of above mentioned firm J.S Security, Avtar Singh and Seema Sheoran never remained pending or was ever decided by him.

It is noteworthy to mention here that the officer has joined U.P. HJS on 19.08.2013. It appears that he had purchased the aforementioned car (June 2013), prior to joining the service.

In this connection, it is submitted that the officer has sold her car through a regular and reputed dealer. There seems to be nothing objectionable as per the Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956, which is as follows:-

24 (2):- "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad also nominated for "Disposal of the

matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the District Ghaziabad, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
