

## **Registrar (J) (Budget)**

May kindly see the online application dated 17.02.2024 of Smt. Pooja Singh, Additional District & Sessions Judge, Gonda regarding grant of permission to use staff car for undertaking personal journey from Gonda to Lucknow on 17.02.2024 for some important personal work.

In her application, Smt. Pooja Singh has stated that she wants to go to Lucknow for some important personal work on 17.02.2024 after the court hours. She wants to use official car bearing registration No. UP 43 G 0233 for this journey. She will pay the charges as per rule. She has, therefore, requested to place her application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid journey. Thereafter, she was asked to intimate as to whether she had performed the journey in anticipation of permission of Hon'ble High Court and if yes, to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms, then intimate about the amount paid. As intimated later by her, it is submitted that she has accomplished her journey on 17.02.2024 from Gonda to Lucknow in official car bearing reg. no. UP 43 G 0233, travelled 789 kms. and has paid an amount of Rs. 1767/- by challan No. C502868 on 05.03.2024 which has been deposited in SBI, Gonda. Copy of Challan can be seen as attachment. She has, therefore, requested that Hon'ble Court may kindly be moved to accord her permission for use of the official vehicle for the above mentioned visit.

In this connection, It is submitted that according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are permitted to use official vehicle for 200 kms per month for personal use & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. She has used the official vehicle for her personal journey from Gonda to Lucknow and has deposited due money, the same is in accordance with the relevant G.O. As such, her request to use official vehicle appears to be considerable.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Siddharth, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal & if His Lordship approves, Smt. Pooja Singh, Additional District & Sessions Judge, Gonda be granted ex-post facto permission to use official vehicle no. UP 43 G 0233 for her personal journey from Gonda to Lucknow on 17.02.2024 as mentioned above, as per the provisions of relevant G.O.?
