May kindly see the online application of Sri Jaseem Khan, Judicial Magistrate, Mainpuri who joined service on 15.11.2019, drawing gross salary of Rs. 1,08,085/- & take home salary of Rs. 88,252/- regarding information about purchase of a new Toyota Innova Crysta (GX MT) 7 Car, allotted reg. no. UP22 AZ9998 (Copy of RC can be seen as attachment namely- Registration Certificate of Car), intimated through application dated 23.02.2024.

Through his application, Sri Jaseem Khan has submitted information about purchase of a new car on 23.06.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Commercial Toyota, Rampur Road, Bareilly, for Rs. 22,98,798/- in total (Copy of invoice can be seen as attachment namely-Tax Invoice of Car), source of money of which is that Rs. 12,00,000/- has been taken as loan from SBI bank, repayable in 84 monthly EMIs of Rs. 19,368/- (Copy of 'loan arrangement letter' can be seen as attachment namely- Loan Sanction Letter), Rs. 10,87,798/- (on 22.06.2023) is stated to have been paid out of his saving bank account (copy of statement of A/c can be seen as attachment namely- Bank Statement/Passbook of Salary A/c), Rs. 11,000/- (on 16.05.2023) is stated to have been paid as advance out of his saving bank account (copy of statement of A/c can be seen as attachment namely- Bank Statement/Passbook of Salary A/c). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

It is pertinent to mention here that the officer has received an amount of Rs. 6,10,000/- (6,09,000/- on 11.06.2023 Rs. 1,000/- on 11.06.2023) for the sale of his old car Maruti Suzuki Ciaz to R.N Motors, Moradabad (Authorized Dealer) (Copy of RC of his old car, Receipt and saving bank A/c can be seen as attachments namely- RC of old car, Delivery/Purchase Receipt of Old Car, Bank Statement/Passbook of Salary A/c).

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Mainpuri for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
