May Kindly see the online application of Sri Hardik Singh, Judicial Magistrate, Ghazipur by which he has requested for grant of permission to appear in the Mains examination of Delhi Judicial Services Examination 2023.

In his application, Sri Hardik Singh has stated that he had earlier sought permission to appear in the preliminary examination of Delhi Judicial Service Examination 2023 through Case Id. S00037462023 and in furtherance of that, he has requested for grant of permission to appear in the Mains Examination of aforesaid exam scheduled for 09.03.2024 and 10.03.2024. He has also enclosed the result of Delhi Judicial Services prelims examination which can be seen as attachment. Thereafter, through online objection, the officer was asked to intimate as to whether he has appeared in the stated Mains examination as the date of the Mains examination of the same got elapsed. In reply, the officer has stated that Mains Examination of DJS-2023 has been re-scheduled via notice dated 05.03.2024 (copy can be seen as attachment) and the Mains Examination would now be conducted on 30.03.2024 and 31.03.2024. He has, therefore, requested to Hon'ble Court to grant him permission to appear in the aforesaid Mains examination of Delhi Judicial Services Examination 2023.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 16.12.2019. It is also pertinent to mention here that the officer has applied for grant of permission to appear in the preliminary examination of Delhi Judicial Services Examination, 2023 through online case Id. S00037462023 and the same is at the level of Hon'ble Judge, Ghazipur. It is also to mention here that from the perusal of other application of the same matter, it appears that the date of Mains exam of DJS 2023 has been rescheduled to 13.04.2024 to 14.04.2024. Now as the officer is seeking for grant of permission to appear in the Mains examination of the Delhi Judicial Services exam 2023 as he has cleared the prelims exam for which he has earlier sought permission. Now, it is on the discretion of His Lordship either to grant him permission to appear in the Mains Examination of the same as he has cleared the preliminary examination or to pass any other order. Permission to appear in such type of written examination may be accorded, but subject to the following conditions

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur for His Lordship's kind perusal and orders to the effect that permission be accorded to Sri Hardik Singh, Judicial Magistrate, Ghazipur to appear in the Mains examination of Delhi Judicial Services Examination 2023, as requested, subject to the conditions mentioned above?
