May kindly see the online application of Sri Sushil Kumar-V, A.D.J. (FTC) Mathura regarding grant of permission to visit Singapore for a period of about 06 days in summer vacation 2024 (tentatively from 03.06.2024 to 08.06.2024).

In his application, Sri Sushil Kumar-V has stated that he wishes to go abroad (Singapore) with his family (his wife and two children) during summer vacation in the month of June - 2024 for a period of maximum 6 days and the approximate expenditure on said trip would be around Rs. 2,12,000/-, as per the quotations of travel operator AVS HOLIDAYS PVT. LTD. (copy of quotation can be seen as attachment). He has also stated that, the quotation is dynamic which may vary by 10 % to 20 % depending upon delay in flights booking and hotel. He has also stated submitted his undertaking which is as follows:-

1. That, by his visit, no dilemma is likely to create before the Government of India or before the Government of Uttar Pradesh.
2. That, such type of request for abroad visit was not refused to him earlier.
3. That, he has not visited any foreign country earlier.
4. That, regarding source of income, he has stated that the he is in HJS Cadre. Moreover in last financial year (2022-2023), he has received salary and allowance of Rs. 23,49,677/- (Gross) and the approximate expenditure (inclusive of air fare, accommodations, meals and visa fees) on said visit to abroad would be around Rs. 2,12,000/- (copy of passbook showing MOD balance of Rs. 5,80,000/- can be seen as attachment), thus he can bear the expenses.

He, has therefore requested to grant him permission to visit Singapore alongwith his family in the summer vacation i.e. in June 2024 for the aforesaid period.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, no vigilance/ departmental enquiry is pending against Sri Sushil Kumar-V. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/ departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. It is also pertinent to mention here that the officer has stated that he would visit Singapore for a period of about 06 days in summer vacation 2024 (tentatively from 03.06.2024 to 08.06.2024 as check in and check out dates mentioned in quotation), which includes non working days of the Hon'ble Court. Now its upto the discretion of Hon'ble The Chief Justice and Hon'ble Administrative Judge, Mathura; either to grant him permission to visit Singapore for a period of about 06 days in summer vacation 2024 or to pass any other order. In this connection. It is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Recently, vide order dated 30.11.2023 relating to re-constitution of Committees, Hon'ble The Acting Chief Justice has been pleased to change the single Judge Committee appearing at sl. no. 3 of the list of Committees dated 23.04.2023- last modified on 29.08.2023, and Hon'ble Mr. Justice Anjani Kumar Mishra is nominated in the said Committee, to deal with the matters relating to grant of permission to Judicial Officers to visit abroad.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura for kind perusal and if His Lordship approves, Sri Sushil Kumar-V, A.D.J. (FTC) Mathura may be granted permission to visit Singapore alongwith his family for a period of about 06 days in summer vacation 2024, as requested, subject to approval by single Judge Committee of Hon'ble Mr. Justice Anjani Kumar Mishra, as per

Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 30.11.2023 of Hon'ble The Acting Chief Justice relating to re-constitution of Committees, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with him, may be handed over by him before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
