May kindly see the earlier office note dated 14.03.2024 regarding grant of permission to Sri Vishnu Chandra Vaish, Additional District & Sessions Judge, Farrukhabad to purchase plot no. C-228 measuring 208.17 sq. m. at DLF Garden City, village Purseni, Tehsil Mohanlalganj, Distt. Lucknow as per 'Agreement to Sell' deed dated 02.03.2024, submitted before Hon'ble Dr. Justice Yogendra Kumar Srivastava, Administrative Judge, Farrukhabad, whereupon His Lordship has been pleased to pass the following order dated 23.03.2024:-

"Officer be directed to furnish whether he has received Rs. 27,00,000/- as arrears of second national judicial pay commission. If yes, furnish the details."

The order was communicated to the officer vide communication dated 23.03.2024

In compliance with the Court's order, the officer vide his communication dated 28.0.3.2024 has stated that he has received Rs. 20,40,781/- as first installment of arrears of Second National Judicial Pay Commission. The said amount of Rs. 20,40,78.00 has been credited in his savings bank account no. 30613665548 on 21.03.2024 which is being shown in the pass-book of his account. In this regard, the copy of the pass-book of his savings bank account no. 30613665548 is being annexed for kind perusal of the Hon'ble Court (Copy of pass book can be seen in the attachment dated 28.03.2024 named 'Document"). After the credit of the first installment of the arrears of SNJPC, the total balance in his aforesaid account as on 28.03.2024 is Rs.78,25,700.46. It is also pertinent to mention that the total balance amount to be paid to the seller for the concerned plot is only Rs. 70 lacs. The rest amount of the arrears approximately Rs. 6.5 lacs is about to be paid to him by the end of this month itself. He has, therefore, submitted the required information before the Hon'ble Court for kind perusal and further necessary action.

As such, the supplementary details in compliance with Hon'ble Court's order in connection with the purchase of the plot are likely to be submitted before His Lordship.

Under the above-mentioned facts & details submitted by the officer, may therefore, if approved, the matter may be submitted before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Farrukhabad for His Lordship's kind perusal & further orders regarding grant of permission to the officer to purchase plot no. C-228 measuring 208.17 sq. m. at DLF Garden City, village Purseni, Tehsil Mohanlalganj, Distt. Lucknow from Smt. Preeti Rastogi D/o Sri Ram Kumar Rastogi R/o Rastogi sadan, Stree Satsang sadan wali gali poorvi dikshitana, Gola Gokarnnath, Kheri for Rs. 92,25,260/- as requested, subject to the condition that the relevant papers of the transaction alongwith copy of the sale deed be furnished by him immediately on completion of the transaction?
