

Registrar (Judicial) (Budget)

May kindly see the online application of Sri Sagar Singh, Additional Civil Judge (Junior Division), Hasanpur-Amroha regarding grant of permission to visit Europe alongwith his wife, Smt. Sakshi Singh, who is also a judicial officer (officer id UP 2525) from 12.06.2024 to 23.06.2024.

In his application, Sri Sagar Singh has stated that he got married to Sakshi Singh, Additional Civil Judge (Sr. Div) Ayodhya, ID- UP2525 on 19.01.2024 and wishes to visit Europe during the summer vacation from 12.06.2024 to 23.06.2024 and he holds a valid passport bearing number R7773208 (copy of the same can be seen as attachment). He has also stated that expenses of the proposed trip would be borne by the officer and his wife jointly (copy of his S.B. A/c no. 6314000400003690 having balance of Rs. 1,51,397/- can be seen as attachment). He has also enclosed the copy of the passbook of his wife, Smt. Sakshi Singh, Additional Civil judge (S.D.)/ACJM having balance of Rs. 13,97,444/- which also can be seen as attachment and the proposed expense of the said foreign trip is approximately Rs. 3,00,000/-. Thereafter through online objection the officer has been asked to submit declaration and also be asked to clarify his visit duration, as his proposed visit is of 12 days whereas only 10 days recess is granted to Judicial Officers. In reply the officer has submitted following declaration:-

1. That by his abroad visit, no dilemma is likely to create before the Government of India or before Government of Utar Pradesh.
2. That such type of request for abroad visit was not refused to him earlier.
3. That he has never visited any foreign country, before and after his date of joining
4. He has granted 10 days recess which he wishes to avail from 12.06.2024 to 21.06.2024, however 22.06.2024 and 23.06.2024 are fourth Saturday and sunday respectively which are holidays on which the courts shall remain closed. Due to this he has sought permission for 12 days.
5. He has also submitted the copy of passport (copy can be seen as attachment)

He has, therefore, requested to place his request before Hon'ble Court to grant him permission to visit Europe alongwith his wife.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, provided by concerned sections, no vigilance/ departmental enquiry is pending against Sri Sagar Singh. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during

certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. Now, in the instant case the officer is going to visit Europe alongwith his wife, Smt. Sakshi Singh, who is also a Judicial Officer from 12.06.2024 to 23.06.2024, which includes sunday, fourth saturday and 10 days recess (summer vacation), thus, this trip appears to be a pleasure trip which falls during non working days of the Court. However, it is on the discretion of the Hon'ble High Court either to grant him permission or to pass any order which deems to be proper. Here, it is also to point out that his wife Smt. Sakshi Singh has also separately applied for the same permission, which is also being processed through a separate e-service Id S00041032024. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble The Chief Justice or any member of the Administrative Committee authorised by Hon'ble The Chief Justice. Hon'ble The Acting Chief Justice has been pleased to change the single Judge Committee appearing at sl. no. 3 of the list of Committees dated 23.04.2023- last modified on 29.08.2023, and Hon'ble Mr. Justice Anjani Kumar Mishra is nominated in the said Committee, to deal with the matters relating to grant of permission to Judicial Officers to visit abroad.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Amroha for kind perusal and if His Lordship approves, Sri Sagar Singh, Additional Civil Judge (Junior Division), Hasanpur-Amroha may be granted permission to visit Europe along with his wife, Smt. Sakshi Singh, who is also a Judicial Officer from 12.06.2024 to 23.06.2024, as requested, subject to approval by single Judge Committee of Hon'ble Mr. Justice Anjani Kumar Mishra, as per Hon'ble High Court's Circular Letter No. 16/IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 30.11.2023 of Hon'ble The Acting Chief Justice relating to re-constitution of Committees, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with him, may be handed over by him before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
