May kindly see the online application received from Sushri Arushi Sharma, Civil Judge (Junior Division) (FTC) (Crime Against Women), Etawah regarding information about transfer of i-10 Magna car from her father's name into her own.

Sushri Arushi Sharma in her application has stated that she had applied for transfer of vehicle registration no. UP85Y4303 registered on the name of her father Shri D.K Sharma before the Regional Transport Office Mathura through online mode before joining the services on 04.01.2024, the e-receipt of which can be seen as attachment). The said vehicle has been transferred by the Regional Transport Office on her name on 16.01.2024 and the new Registration certificate has been issued on 18.01.2024, which is also attached with the application. Copy of 'Consent Letter' of her father can be seen as attachment. It is therefore, requested that the information regarding gifting as well as transfer of the aforementioned car from her father's name into her own may be placed before kind perusal of this Hon'ble Court.

In this connection, it is submitted that the relevant rule relating to transfer of movable property [Rule-24 (2) of U.P. Government Servant's conduct Rule-1956] & rule relating to gift (Rule 11 of the U.P. Government Servant's Conduct Rules, 1956) runs as under:

24 (2) "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority.

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

- 11. Gifts:-A government servant shall not without previous approval of Government :-
- (a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or
- (b) Permit any member of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relative.

It is further submitted that the i-10 Magna car has been gifted to her by her father out of natural love and affection and is the closest blood relative being father & daughter in relation. Thus, there seems to be nothing objectionable as per rule referred to above.

May, therefore, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Shamim Ahmed, Administrative Judge, Etawah, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Etawah, for His Lordship's kind perusal and information under Rule (11) & Rule (24) (2) of U.P. Government Servant's Conduct Rules, 1956?
