May kindly see the online application of Sri Sudhakar Dubey, Additional District & Sessions Judge, Meerut, who joined service on 18.05.2009, drawing gross salary of Rs. 2,57,373/- & take home salary of Rs. 1,75,676/- regarding information about purchase of a new Innova Crysta Car, allotted reg. no. UP32NZ 2116 (Copy of RC can be seen as attachment namely- R.C), intimated through application dated 16.03.2024.

Through his application, Sri Sudhakar Dubey has submitted information about purchase of a new car on 19.10.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Sunny Motors Pvt. Ltd., Kanpur, for Rs. 23,13,832/- in total (Copy of invoice can be seen as attachment namely- Tax invoice of car, source of money of which is that Rs. 9,05,181/- has been taken as loan from Toyota Financial Services India Ltd., repayable in 36 monthly EMIs of Rs. 28,876/-(copy of 'loan document' can be seen as attachment namely- loan detail), Rs. 10,000/- (on 28.09.2023) is stated to have been paid as booking from his saving bank A/c (copy of statement of A/c can be seen as attachment namely- Arrear SNJPC & booking detail) and Rs. 14,00,000/- (Rs. 9,00,000/- on 17.10.2023 Rs. 5,00,000/- on 17.10.2023) is stated to have been paid out of his saving bank account (copy of statement of A/c can be seen as attachment namely- Transfer by cheque), The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

It is pertinent to mention here that the officer has received an amount of Rs. 12,12,606/- (Rs. 8,79,495/- on 13.09.2023 Rs. 3,33,111/- on 13.09.2023) as an arrear of IInd SNJPC (copy of statement of A/c can be seen as attachment namely- Arrear SNJPC & booking detail)

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Meerut also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Meerut for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
