May kindly see the online requisition/application dated 16.03.2024 of Sri Sachin Kumar Dixit, the then Additional Chief Judicial Magistrate, Moradabad, presently posted as Civil Judge (Senior Division), Chitrakoot, for inclusion of Ph.D. Degree in his service records and addition of the realted title i.e. prefixing the word "Dr." before his name. In view of the above, Sri Sachin Kumar Dixit has furnished the duly scanned & attested copy of Degree Qualification of Ph.D. as well as copy of permission letter of this Hon'ble Court to pursue the aforesaid course, as supporting documents for the same.

An objection dated 02.05.2024 was raised by this office to furnish the clearly scanned & duly attested copy of Ph.D. degree qualification as well as copy of permission letter of Hon'ble Court to pursue the aforesaid Ph.D. course. In reply thereto, Sri Sachin Kumar Dixit has furnished the duly attested copy of desired documents by attachment dated 14.06.2024.

In this connection, it is submitted that Sri Sachin Kumar Dixit, joined U.P. Judicial Services on 13.01.2017 as Judicial Magistrate, Kannauj. Besides, as evident from submitted copy of degree of Ph.D., Sri Sachin Kumar Dixit was awarded the degree of Doctor of Philosophy (Ph.D.) on 30.12.2022 for the year 2022 from the Institute of Legal Studies of Sri Ramswaroop Memorial University, Lucknow, on the topic "Human Rights Issues in India Related to Narcotic Drugs and Psychotropic Substances : A Socio Legal Study" after joining the U.P. Judicial Services, with due permission of this Hon'ble Court to pursue the aforesaid course.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of Ph.D. degree may be included in his service-records & prefixing word "Dr." be added before the name of Sri Sachin Kumar Dixit, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems appropriate that aforesaid online application dated 16.03.2024 of Sri Sachin Kumar Dixit, Civil Judge (Senior Division), Chitrakoot may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, If approved, the matter may kindly be placed before Hon'ble Mr. Justice Syed Qamar Hasan Rizvi, Administrative Judge, Chitrakoot, for His Lordship's kind perusal and approval to the effect that a copy of aforesaid online application dated 16.03.2024 along with attested copy of Ph.D. degree as well as attested copy of form of U.P. Nyayik Sewa of Sri Sachin Kumar Dixit, Civil Judge (Senior Division), Chitrakoot may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders in the instant matter ?
