May kindly see the online requisition dated 20.03.2024 of Sri Lakhwinder Singh Sood, Spl. Judge (SC/ST, Pev. of Atroci. Act) Mahoba, whereby he has requested for inclusion of his LL.M. qualification in his service records. In support of the same, Sri Lakhwinder Singh Sood has furnished his LL.M. credentials comprising attested copies of Marksheets of 1st year dated 09.02.2022 and 2nd year dated 22.06.2023 and Degree Qualification dated 30.11.2023 as well as copy of the online permission letter for pursuing the aforesaid course alongwith a Certificate dated 13.08.2018 of the Director, Directorate of Distance Education, Kurkshetra University, Kurkshetra, Haryana and letter no. F.No. 122-1/2017 (DEB-IV) dated 25.06.2018 of Education Officer of UGC, as supporting documents for inclusion of the aforesaid degree in his service records.

In this connection, it is pertinent to mention here that Sri Lakhiwinder Singh Sood in his application has submitted that he pursued the aforesaid LL.M. course after joining the Higher Judicial Services on being granted the permission of this Hon'ble Court, the copy of online permission letter has been attached hereon by attachment dated 06.05.2024 under the heading 'Approval By the HC'.

In this regard, an objection dated 29.03.2024 was raised by this office for furnishing the attested copies of LL.M. credentials as well as copy of documents related recognition of Kurushetra Univeristy, Kurukshetra, Haryana and approval of the aforesaid course. In reply thereto, he has furnished desired documents by attachments dated 06.05.2024.

In this context, it is further submitted that Sri Lakhwinder Singh Sood, aforesaid joined the U.P. Higher Judicial Services on 31.07.2019 as Additional District Judge, Meerut. Besides, as evident from submitted attested copies of Marksheets of both the years and the Degree qualification of LL.M., he has completed LL.M. course and was subsequently awarded degree from Kurukshetra Univeristy, Kurukshetra on 30.11.2023 for the examination year 2022, thus the said qualification may be included in his service records.

It is further submitted that the appointing authority of Judicial Officers, is the Government of U.P., thus the said qualification of LL.M. degree may be included in the service records of Sri Lakhwinder Singh Sood, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems appropriate that the aforesaid online requisition dated 20.03.2024 of Sri Lakhwinder Singh Sood, Spl. Judge (SC/ST, Pev. of Atroci. Act), Mahoba may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Prashant Kumar, Administrative Judge, Mahoba for His Lordship's kind perusal and order to the effect that a copy of online requisition dated 20.03.2024 alongwith the copy of Marksheets (both years) and Degree of LL.M., as well as attested copy of form of U.P. Higher Judicial Services of Sri Lakhwinder Singh Sood, Spl. Judge (SC/ST, Pev. of Atroci. Act), Mahoba, may be sent to the Joint Secretary, Appointment Section- 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P., in the instant matter?
