May kindly see the online application of Sri Griesh Kumar Vaish, District and Sessions Judge, Auraiya regarding grant of permission to use staff car for undertaking journey from Auraiya to Bareilly for personal work from 23.03.2024 to 26.03.2024.

In his application, Sri Griesh Kumar Vaish has stated that the courts are closed from 23.03.2024 to 26.03.2024 because it is fourth Saturday on 23.03.2024, on 24.03.2024 it is Sunday, 25.03.2024 it is Holiday of Holi and 26.03.2024 (Local Holiday in Judgeship Auraiya). It is also submitted that he desires to leave the station in the morning of 23.03.2024 upto the evening of 26.03.2024 for going to Bareilly for personal work. During the said period, he desires to use the official car bearing Registration No. UP 79G0257 on payment of usual charges as per rules. He has, therefore, requested to place his application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid journey. It has been further asked from the officer that whether he has performed the journey in anticipation of permission of Hon'ble High Court and if yes to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms, then to intimate about the amount paid. As intimated later by him, it is submitted that he has accomplished his journey from Auraiya to Bareilly in official car, travelled 1013 kms, taking advantage of 200 kms out of 1013 kms, the remaining 813 kms were paid the total amount Rs. 2439/- (as per rate of Rs 3 /KM), deposited through challan no. D03512 dated 03.04.2024 in SBI, Auraiya (Copy of Challan can be seen as attachment). He has, therefore, requested that Hon'ble Court may kindly be moved to accord him permission for use of the official vehicle for the above mentioned visit.

In this connection, it is submitted that the date for his visit from Auraiya to Bareilly is passed over & in the meantime the journey has already been performed by the officer as records shows. He has used the official vehicle for his personal journey from Auraiya to Bareilly which is in accordance with Rules & the G.O. and he has deposited due money, his request to use official vehicle appears to be considerable.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Manish Kumar Nigam, Administrative Judge, Auraiya Judgeship for His Lordship's kind perusal & orders regarding grant of ex-post facto permission now to use official vehicle by Shri Griesh Kumar Vaish, District and Sessions Judge, Auraiya for the journey mentioned above, as per the provisions of relevant Rules and G.O.?
