May kindly see the online application of Sri Pushpender Singh, Special Secretary & Additional L.R (Nyay Vibhag), Govt. Of U.P., Lucknow who joined service on 05.07.2006, drawing gross salary of Rs. 2,82,502/- & take home salary of Rs. 1,98,236/- regarding information about purchase of a new Hyundai Exter 1.2 MT Kappa Car, allotted reg. no. UP32 NZ6532(Copy of RC can be seen as attachment namely- Registration certificate of Vehicle), intimated through application dated 29.03.2024.

Through his application, Sri Pushpender Singh has submitted information about purchase of a new car on 26.10.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Aspire Automobiles Pvt. Ltd., Gautam Buddha Nagar for Rs. 8,25,987/- in total (Copy of invoice can be seen as attachment namely- Retail invoice and receipt), source of money of which is that Rs. 6,44,300/- has been taken as loan from SBI Bank, Lucknow, repayable in 60 monthly EMIs of Rs. 13,313/-(copy of 'loan arrangement letter' can be seen as attachment namely- Loan Sanction Letter), Rs. 46,687/- (Rs. 20,000/- on 25.10.2023 Rs. 51/- on 27.10.2023 Rs. 26,636/- on 26.10.2023) is stated to have been paid out of his saving bank account (copy of statement of A/c can be seen as attachment namely- Savings Bank Statement), Rs. 1,35,000/- is stated to have been paid in exchange of his old car (Copy of Buying Receipt can be seen as attachment namely- Exchange buying of old car receipt). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Lucknow for Her Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
