The dealer from whom the said car has been purchased by the officer is a regular and reputed authorised dealer of Skoda cars and, is neither related to him in any way nor any case is pending/decided in his court. The tax invoice is in the attachment namely- "Tax Invoice". He has also submitted that the delay in sending the information is due to workload, for which he seeks an apology.
