May kindly see the online requisition dated 30.03.2024 of Sri Gaurav Singh, Civil Judge (Junior Division), Mathura, whereby he has requested for inclusion of his LL.M. qualification in his service records. In support of the same, Sri Gaurav Singh has furnished his LL.M. credentials comprising attested copies of Marksheets of 1st year dated 16.08.2021 and 2nd year dated 24.08.2022 and Degree Qualification dated 29.12.2023 as well as copy of the online permission letter for pursuing the aforesaid course alongwith a letter/certificate dated 13.08.2018 of the Director, Directorate of Distance Education, Kurukshetra University, Kurukshetra, Haryana and letter no. F.No. 74-2/2018 (DEB-I) dated 18.10.2018 of Secretary of UGC, as supporting documents for inclusion of the aforesaid degree in his service records.

In this connection, it is pertinent to mention here that Sri Gaurav Singh in his application has submitted that he pursued the aforesaid LL.M. course before joining the judicial services and after due permission of this Hon'ble Court, she appeared in the said examination, the copy of online permission letter has been attached hereon by attachment dated 30.03.2024 under the heading 'Approval letter of Hon'ble Court'.

In this regard, an objection dated 02.04.2024 was raised by this office for furnishing the clearly scanned & attested copies of LL.M. credentials as well as copy of documents related recognition of Kurukshetra Univeristy, Kurukshetra, Haryana and approval of the aforesaid course. In reply thereto, he has furnished desired documents by attachment dated 10.09.2024.

In this context, it is further submitted that Sri Gaurav Singh, aforesaid joined the U.P. Judicial Services on 16.11.2019 as Additional Civil Judge (Junior Division), Varanasi. Besides, as evident from submitted attested copies of Marksheets of both the years and the Degree qualification of LL.M., he has completed LL.M. course and was subsequently awarded degree from Kurukshetra Univeristy, Kurukshetra on 29.12.2023 for the examination year 2021, thus the said qualification may be included in his service records.

It is further submitted that the appointing authority of Judicial Officers, is the Government of U.P., thus the said qualification of LL.M. degree may be included in the service records of Sri Gaurav Singh, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems appropriate that the aforesaid online requisition/application dated 30.03.2024 of Sri Gaurav Singh, Civil Judge (Junior Division), Mathura may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura for His Lordship's kind perusal and order to the effect that a copy of online requisition/application dated 30.03.2024 alongwith the copy of Marksheets (both years) and Degree of LL.M., as well as attested copy of form of U.P. Nyayik Sewa of Sri Gaurav Singh, Civil Judge (Junior division), Mathura, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P., in the instant matter?
