May kindly see the online application of Sri Vivek Kumar-I, Additional District & Sessions Judge, Bulandshahar who joined service on 19.02.2018, drawing gross salary of Rs. 3,08,085/- & take home salary of Rs. 2,24,336/- regarding information about purchase of a new Mahindra Bolero Neo 8 Car, allotted reg. no. UP15 EJ2525 (Copy of RC can be seen as attachment namely- invoice rc insurance, page no. 2), intimated through application dated 12.04.2024.

Through his application, Sri Vivek Kumar-I has submitted information about purchase of a new car on 28.02.2024 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Jai Kumar Arun Kumar Pvt. Ltd.(Mahindra Authorized Dealer), Meerut for Rs. 11,88,243/- in total (Copy of invoice can be seen as attachment namely- invoice rc insurance, page no. 1), source of money of which is that Rs. 10,25,000/- has been taken as loan from Prathama U.P. Gramin Bank, Bulandshahar, repayable in 84 monthly EMIs of Rs. 16,284/-(copy of 'loan arrangement letter' can be seen as attachment namely- loan detail, Rs. 51,000/- is stated to have been paid in cash as booking amount by his uncle (copy of cash receipt can be seen as attachments namely- booking amount, page no. 2), Rs. 43,000/- is stated to have been paid in exchange of his old car (copy of purchase receipt can be seen as attachment namely-old car value) Rs. 13,390/- is stated to have been paid in cash for car accessories (copy of cash receipt can be seen as attachment namely- accessories), Rs. 42,201/- is stated to have been paid out of his Union Bank of India A/c (copy of statement of A/c can be seen as attachment namely- payment by vivek kumar, page no. 4), Rs. 16,500/- is stated to have been paid out of his ICICI bank Account (copy of statement of A/c can be seen as attachment namely- car number of choice). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

It is noteworthy to mention here that the Officer stated his Aunt (chachi) Smt. Chanderbala gifted her old Sentro car (UP-25P-2522) to him during his legal practice ( prior to joining this service), which she bought in 2003. The Sentro car had been used by his uncle Sri Brijpal Singh Tomar Advocate Meerut, the said Sentro car has become 19 years old, hence could not be used in N.C.R. (National Capital Region) as per law. He further stated that his uncle Sh Brijpal Singh Tomar who is about 73 years old need a new car and could not obtained car loan due to his old age, so he booked new car in the officer's name and paid Rs 51,000 as booking amount. The officer also applied for car loan from Prathama UP Gramin Bank Bulandshahr. Finally, the officer bought a Mahindra Neo 8 for his uncle, which is being used by his uncle at Meerut and the installments are being paid from the salary of the officer.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice J.J. Munir, Administrative Judge, Bulandshahar also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and

permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Bulandshahar for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
