May kindly see the online application of Sushri Preeti Giri, Addl. Civil Judge (Senior Division)/ ACJM, Ayodhya regarding grant of permission to visit Malaysia and Thailand from 10.06.2024 to 19.06.2024 to visit her first cousin.

In her application, Sushri Preeti Giri has stated that she wants to visit Malaysia and Thailand to visit her first cousin during summer vacation 2024 i.e. from 10.06.2024 to 19.06.2024 and the proposed expenses of the trip would be borne by her from her SBI salary bank account. Thereafter, through online objection, the officer was asked to intimate the expenditure and also be asked to submit copy of passport and declarations in the light of Hon'ble Court Circular letter dated 27.05.2017 . in reply of the same, the officer has submitted following declaration:-

- 1. That by her abroad visit, no dilemma is likely to create before the Government of India or before Government of Uttar Pradesh.
- 2. That such type of request for abroad visit was not refused to her earlier.
- 3. She has earlier visited London from 25.12.2022 to 31.12.2022 with the permission of Hon'ble High Court.
- 4. Estimated expenditure of the aforesaid trip would be Rs.2,00,000/- and the same would be borne by the officer from her salary account (copy of account statement showing balance amount of Rs. 26,48,105/- can be seen as attachment).
- 5. Copy of passport can also be seen as attachment.

She has, therefore, requested to grant her permission to visit Malaysia and Thailand for the aforesaid duration.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, provided by concerned sections, no vigilance/ departmental enquiry is pending against Sushri Preeti Giri. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IVf-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. Now, in the instant case the officer is going to visit Malaysia and Thailand to visit her first cousin during summer vacation (recess) 2024 i.e. from 10.06.2024 to 19.06.2024 which includes non working days of the Hon'ble Court, this trip appears to be a pleasure trip which falls during non working days of the Court. However, it is on the discretion of the Hon'ble High Court either to grant her permission or to pass any order which deems to be proper. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble The Chief Justice or any member of the Administrative Committee authorised by Hon'ble The Chief Justice. Hon'ble The Acting Chief Justice has been pleased to change the single Judge Committee appearing at sl. no. 3 of the list of Committees dated 23.04.2023- last modified on 29.08.2023, and Hon'ble Mr. Justice Anjani Kumar Mishra is nominated in the said Committee, to deal with the matters relating to grant of permission to Judicial Officers to visit abroad.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Faizabad (Ayodhya) for kind perusal and if His Lordship approves, Sushri Preeti Giri, Addl. Civil Judge (Senior Division)/ ACJM, Ayodhya may be granted permission to visit Malaysia and Thailand from 10.06.2024 to 19.06.2024, as requested, subject to approval by single Judge Committee of Hon'ble Mr. Justice Anjani Kumar Mishra, as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 30.11.2023 of Hon'ble The Acting Chief Justice relating to re-constitution of Committees,

as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
