In view of the above, Sri Nazim Akbar has furnished the duly scanned & attested copy of Degree Qualification as well as copy of permission letter of this Hon'ble Court to pursue the aforesaid course, as supporting documents for the same.

In this connection, it is submitted that Sri Nazim Akbar, joined U.P. Judicial Services on 15.11.2019 as Additional Civil Judge (Junior Division), Muzaffar Nagar. Besides, as evident from submitted copy of degree of Ph.D., Sri Nazim Akbar was awarded the degree of Doctor of Philosophy (Ph.D.) on 24.02.2024 for the year 2023 from the Faculty of Law, University of Delhi, on the topic "Pharmaceutical Patents in India: A Critical Analysis of Public and Private Interests " after joining the U.P. Nyayik Sewa of Sri Nazim Akbar, Civil Judge (Junior Division), Jewar-Gautambuddha Nagar, Gautambuddha Nagar may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders in the instant matter ?
