May kindly see the online application of Smt. Pooja Singh, Additional District & Sessions Judge, Gonda regarding grant of permission to use staff car for undertaking journey from Gonda to Lucknow for some important personal work on 16.05.2024 after court hours.

In her application, Smt. Pooja Singh has stated that she wants to go to Lucknow on 16.05.2024 after court hours. She wants to use official car bearing registration no. UP 43 G 0233 for the journey. She will pay the charges as per rule. She has, therefore, requested to place her application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid journey. It has been further asked from the officer that whether she has performed the journey in anticipation of permission of Hon'ble High Court and if yes to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms, then to intimate about the amount paid. As intimated later by her, it is submitted that she has accomplished her journey from Gonda to Lucknow in official car. During the period from March-2024 to June-2024, she has travelled total distance 4649 Km in which 3449 Km exceeds from the permissible limit of 1200 Km in 4 months. She has paid Rs. 10347/- for excess distance traveled by her through Challan Receipt No. GB08251 (Copy of Challan can be seen as attachment). She has, therefore, requested that Hon'ble Court may kindly be moved to accord her permission for use of the official vehicle for the above mentioned visit.

In this connection, It is submitted that as per rule mention in subparagraph (G) of Paragraph 5 of Govt. G.O. No. 140/Two-4-2024-45(1)/2020TC Niyukti Anubhag-4 dated 28.02.2024, 200 km. per month has been increased to 300 km. per month. Thus, the officers are permitted to use official vehicle for 300 kms for personal use of the staff car per month & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. She used the official vehicle for her personal journey from Gonda to Lucknow and has deposited due money, the same is in accordance with the relevant G.O. As such, her request to use official vehicle appears to be considerable.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Siddharth, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal & orders regarding grant of ex-post facto permission now to use official vehicle by Smt. Pooja Singh, Additional District & Sessions Judge, Gonda for the journey mentioned above, as per the provisions of relevant Rules and G.O.?
